#### I. PRIMARY PURPOSE AND FUNCTION

The Behavioral Health Clinician is part of the Asian Pacific Development Center (APDC) Specialty Mental Health Clinic, a foundational part of the organization's integrated system of care. The clinician provides mental health services to a largely Asian American Pacific Islander (AAPI), non-English speaking refugee and immigrant population. The clinician is also part of a multidisciplinary, multicultural team and works closely with psychiatrists, clinicians, community navigators/interpreters, case managers, a health care coordinator, medical providers, and other staff/agencies involved in the client's care. Job duties include but are not limited to the list below.

#### JOB RESPONSIBILITIES

- Provide direct clinical services to behavioral health clients that include individual, couples, family therapy, group therapy, skills training and development groups, and psychosocial rehabilitation services.
- Provide mental health screenings and comprehensive intake evaluations to determine DSM-V diagnoses, appropriate treatment/service planning, and referrals for psychiatric medication management.
- Provide referrals to APDC's other integrated services, as appropriate, including primary care, adult education (ESL, citizenship, job readiness classes), victim's services, youth programs and legal aid.
- Provide clinical case management in order to gain access to needed medical, social, educational, and other services. This may involve various telephone contacts, case staffing/meetings, and written reports or correspondence.
- Provide consultation and education of both systems professionals as well as AAPI immigrant and refugee communities, as appropriate.
- Provide community outreach and education to community members about APDC's behavioral health and other integrated services.
- Maintain client records or clinical charts as required by minimum professional standards of care in the State of Colorado and/or as specified by funding sources such as Medicaid and Medicare.
- Provide direct crisis intervention and management with clients, as needed.
- Attend and participate at appropriate meetings, trainings, conferences, etc. as related to professional

duties and responsibilities.

- Perform other tasks and duties as assigned by supervisor or designee.

## II. SKILLS/REQUIREMENTS

- At least a master's degree in social work, counseling, psychology or related field
- At least three years of experience in providing direct clinical services
- Licensed in Colorado or licensed-eligible within one year
- Experience working with immigrants, refugees, trauma, integrated care
- Ability to work with well using interpreters
- Experience working with older adults, children and families, a plus
- Knowledge of systems in the U.S. and in Colorado
- Knowledge of the AAPI community in Colorado
- Ability to work collaboratively with multi-cultural, multi-disciplinary team
- Bilingual fluency is highly desirable
- Excellent oral and written communication skills
